**Re: Pending Efforts to Preserve *Habeas Corpus* Jurisdiction Relating to  
Guantánamo Prisoners**

Dear Senator or Congressperson:

We are members of the Oregon legal community who ask that you support pending efforts to ensure that the United States District Court in Washington, D.C. has jurisdiction over *habeas corpus* claims brought by Guantánamo Bay prisoners. As you know, in *Rasul v. Bush*, 542 U.S. 466 (2004) and *Hamdan v. Rumsfeld*, 126 S. Ct. 2749 (2006), the United States Supreme Court ruled that the federal district court in Washington, D.C. has jurisdiction to hear those claims. In the Detainee Treatment Act (2005) and the Military Commissions Act (2006), Congress purported to strip this court of jurisdiction to consider the *habeas corpus* claims of Guantánamo prisoners.

We urge you to support legislation that ensures that the federal courts retain jurisdiction in these matters.

Some of us have experience as prosecutors, some as defense counsel, and others have not been directly involved in the criminal justice process. Some of us are Republicans, some of us are Democrats, and some of us are unaffiliated with a political party. What we have in common

is our commitment to due process and the rule of law, the pillars of our nation's proud legal tradition.

Currently, only ten of the approximately 400 men held at Guantánamo have been charged with war crimes before military commissions, and plans have been announced to charge 14 more men who were transferred in 2006 to Guantánamo from holding sites around the world. That leaves approximately 375 men who under present policy will never be brought before a military commission. Most of them have been held for almost five years without the opportunity to have their cases heard by an impartial tribunal. These men have filed petitions for *habeas corpus*, the only meaningful method to challenge the legality of their detention.

The judiciary must have the ability to review decisions to detain indefinitely men the Executive Branch deems "enemy combatants," especially where, as here, no charges have been brought and the prisoners are denied prisoner of war status. For example, someone who was detained because of mistaken identity must have recourse to establish that fact before an impartial tribunal.

The right of *habeas corpus* was enshrined in the Constitution by our Founding Fathers as the means by which anyone who is detained by the Executive may challenge the lawfulness of his detention. It is a vital part of our system of "checks and balances" and an important safeguard against mistakes which can be made even by the best intentioned government officials.

We urge you to uphold the fundamental rights that countless Americans have fought and died for, and to ensure that the men at Guantánamo have the right to challenge their detentions in a court of law. Thank you very much for your consideration.<sup>1</sup>
