This Diversion Agreement is entered into pursuant to ORS 135.881 to ORS 135.901 between the defendant, represented by Dan E. Neal and the City Prosecutor for the City of Eugene. After reviewing this case and the criteria set forth in ORS 135.886(2), it appears that diversion is an appropriate disposition of this charge. A separate order staying this case shall be entered herein. Upon the defendant's compliance with the Agreement this case shall be dismissed pursuant to ORS 135.901(2). By signing this Agreement the defendant expressly and voluntarily waives his right to a speedy trial during the term of this Agreement, as required by ORS 135.896. The conditions of this Agreement, pursuant to ORS 135.891, are as follows:

(1) That the defendant shall obey all laws and conduct himself as a peaceful law abiding citizen throughout the six-month term of this diversion agreement;

(2) That the defendant agrees that his conduct at the time alleged in the accusatory instrument on file herein was wrongful; however, this admission is not intended by any party to this agreement as an admission of criminal wrongdoing by the defendant and should not be construed as an admission that defendant committed the offense charged herein; That the defendant shall refrain from having any contact with (4) That the defendant shall pay costs to the court in the sum of \$250.00, said sum to be deducted from the defendant's bail posted herein, with the balance of said bail to be refunded to defendant at this time; That the defendant shall reimburse for her medical expenses incurred herein within seven (7) days of the time she presents copies of her medical bills to defendant; represents that her bills consist of an emergency room visit and a follow up visit for suture removal with the cost of such treatment estimated in the range of \$400.00 to \$500.00; defendant shall have the right to an evidentiary restitution hearing, if he so requests, concerning the reasonableness and necessity of said medical bills; (6) Defendant shall satisfactorily complete 20 hours of community service by July 1, 1994; 14 For valuable consideration as set forth herein, hereby forever releases and discharges Jefferson Daniel Smith from any and all further claims she may have against him arising from the conduct alleged in the complaint on file 16 17 DATED: March 2, 1994 19 ISI DAN E.
