NOTICE OF CONVICTION AND ENTRY OF JUDGMENT. You failed to appear for a scheduled hearing on this case. The Court entered a finding of guilty against you, a conviction and a judgment imposing a sentence to pay fines, assessments and costs.

NOTICE OF DRIVER'S LICENSE SANCTION. If you were convicted of a traffic offense, and do not pay your balance within 30 days of this notice, the Court will order your driver's license sanctioned and will notify the Department of Motor Vehicles. A \$15 license suspension assessment will be added to your balance due. You may be required to pay additional fees to the Department of Motor Vehicles to remove the suspension.

NOTICE OF COLLECTION. If you do not pay your balance within 30 days of this notice, your account will be assigned to the Oregon Department of Revenue or to a private collection agency. Collection actions may include seizure of your assets and/or garnishment of your wages.
